Guidelines for Full Paper Submissions

Upon acceptance of your abstract, you are welcome to submit a full paper to be considered for Special Issues of academic journals (optional). The deadline for full paper submission is **22 August 2018**.

Manuscript Length

The recommended length of each full paper is between **4000-8000 words**. This includes the main text and references, but does not include the cover page, tables and figures. Please **do not** use footnotes, endnotes or appendices.

Language

All submissions, presentations and papers shall be in **English**.

Paper Format

Please adhere to the following formatting guidelines in your full paper submission:

- 1) A4 page with 2.5 cm margins
- 2) Times New Roman font, 11 point size
- 3) Single-spaced
- 4) Justify text between margins
- 5) Separate paragraphs with blank line, no indents
- 6) Save as a PDF file less than 2MB in size

Paper Structure

All full papers should have a cover page with the following elements:

- 1) Names of author(s) and affiliation(s) (including department/ unit, organisation/institution and country/territory)
- 2) Email address of corresponding author
- 3) Abstract (between **300-500 words**)
- 4) Up to five keywords, separated by a semicolon

Any tables or figures should be placed at the very end, after the list of references.

Please use no more than three levels of sections, to be formatted as follows:

When citing in-text, please follow the below guidelines:

One author:

Chan (2018) states that ... or ... (Chan, 2018).

Two authors:

Chan and Wong (2018) state that ... or ... (Chan & Wong, 2018).

Three or more authors:

Chan et al. (2018) state that ... or ... (Chan et al., 2018).
